# Tuition fees

You can use the calculator online to find out the fees you need to pay exactly: <u>Calculation of tuition</u> <u>fees | Study at ArtEZ</u> For EU students: € 2.601 (for 2025-2026) For Non EU students: € 11.460 (for 2025-2026)

Payment of the tuition fee in full must be deposited in ArtEZ's bank account no later than 31 August in order to participate in first classes.

ArtEZ offers the possibility to pay in 10 monthly installments which can be registered via Studielink, first installment is due September 24<sup>th</sup>. Authorisation for automated payments must be fully processed no later than 31 August so make sure to start this administrative procedure well in advance.

#### Insurance & not working Insurance for immigration | Study at ArtEZ

Insurance is obligated to live and work in The Netherlands. For (urgent) medical care, but also accident and liability.

ArtEZ offers to arrange this for Non EU students in the first year via AON Student Insurance. You can choose to continue at the end of the year or arrange your own health insurance.

EU students can check their own insurance if they can provide coverage. Coverage includes medical expenses, liability and theft. If not covered we strongly recommend to apply for an (additional) package with AON.

### Insurance & working

Please be aware that the AON Student Insurance does not offer coverage if you are working in The Netherlands. Once you start working you will fall in the regular rates for insurance starting 129,95 euro a month for basic health care with own yearly risk of minimal 385 euro. AON offers this as well including an additional package for liabilities and such at an additional 26,40 a month. However, the student can decide with which company they want to insure themselves. # **Scholarships Non-EU**

- Non EU students can apply for an ArtEZ scholarship before 1 May via Student Affairs. This will grant 50% of the tuition fee per year for the full study. Amount of scholarships are very limited so it can not be guaranteed you will receive it. <u>ArtEZ Scholarship | Study at ArtEZ</u>
- Dutch Ministry also offers a scholarship for the first year of € 5.000. You can apply for this before 1 May via Student Affairs. <u>Holland Scholarship | Study at ArtEZ</u>

# Visa and permit Non-EU plus Financial guarantee Non-EU

ArtEZ applies and facilitates the visa application for the student. In order to do this ArtEZ will need to receive the financial guarantee amount no later than 31 May. This includes the visa application fee (approx.  $\leq$  243), NON-EU tuition fee ArtEZ ( $\leq$  11.460), Health insurance fee for first year of study (optional, approx.  $\leq$  750) and the income requirement set by Dutch Immigration Services ( $\leq$  13.129,44).

Once the application is completed ArtEZ will return the income requirement set by Dutch Immigration Services (€ 13.129,44) to the Dutch or SEPA (eurozone) bank account of the student. All info for Non EU students: <u>brochure\_non-eu.pdf (artez.nl)</u>

#### Course expenses

For first year students still in need of a medical test upon entry we provide a medical test by Sport Medical Centre of Papendal. Costs are approximately € 155 – an invoice will be sent after you concluded the test.

#### Yearly course expenses

#### Medical support – € 70

Students pay a contribution for access to the consultation hours, transition training, medical support at school and during performances, and periodic tests to track condition and health. An invoice for this amount will be sent at the beginning of the academic year.

#### Class excursion – € 40

For participation in the class excursion, we ask each year a contribution of 40 euros. Amount is due after confirmation of participation.

First year – Visit of the Festival Nederlandse Dansdagen in October – excursion includes travel by train, 1 night stay incl. breakfast and a full programme of performances and workshops. Second year – Visit of Festival Spring in May – excursion includes travel by train, full programme of performances.

Third year – Day trips to Amsterdam, Rotterdam & Den Haag – this is an excursion to meet the professional field and includes travel by train, lectures, workshops and performance.

Cost for lunch and dinner during excursions are for own account unless communicated otherwise.

#### Material for study

#### <u>Laptop</u>

To participate in the education you will need a good working laptop.

In second year we will also be introducing editing of your (audition)video's using free available software.

#### Clothing & other

Partipating in classes we will often recommend the use of the certain attire. If (guest) teachers request we will communicate specific needs. ArtEZ will also offer needed attire at occasion, such as kneebraces for first year students starting floor work. We offer pilates mats during Pilates classes, and have an assigned place in the building with mats amongst others available for own training. Needed attire start of school year:

During each year you will be working on own work and productions in projects on which some students spend between 30 and 50 euro.

### Living expenses

Costs of a room or house can vary from  $\notin$  450 to  $\notin$  750 a month not counting utilities. Be aware your room may come without flooring and curtains. That is not uncommon when renting in The Netherlands. Often your first payment will include a security deposit of one or more months rent. If the room is furnished you may pay a monthly service fee on top of the rent.

Depending your housing and contract you will also be subject to paying municipality taxes to Gemeente Arnhem. In some situations you can appeal to Arnhem to waive the payment.

ArtEZ Dance Artist has a closed facebook group 'ArtEZ DM0 to  $DM^{\infty}$ ' uniting new accepted students with current and alumni. Joining gives the opportunity to contact departing students for a possibility to take over rooms and furniture. Link to group:

#### <u>Furniture</u>

Try to buy your furniture second hand. If your budget is bigger but not too big. Second hand stores for furniture, clothing and more are listed on this website: <u>Kringloopwinkels in Arnhem</u> (allekringloopwinkels.nl)

For bedlinen, towels and cooking you or new but cheap furniture you can try IKEA - <u>Welkom bij IKEA</u> <u>Duiven - IKEA</u>

#### <u>Travel</u>

Arnhem has a small well equipped city center. Most locations can be reached walking. A secondhand bike you can purchase around € 400. Investing in a quality chain lock labeled for parking your bike is advised - minimum of ART 2 security cost varies from 30 – 40 euro. You can opt to rent one from <u>www.swapfiets.nl/arnhem</u>, located Vossenstraat 1 in Arnhem, for € 24 euro a month. This includes 48 hour repair service and replacement if stolen.

Quite a number of students purchase a Weekend Vrij travel subscription from NS for approximately 36,95 euro a month. Allowing travel in The Netherlands by train free of cost in weekend and public holidays.
